#### **Health Effects**

Acute Health Effects: From MSDS

Inhalation: Exposure to vapor or mist may irritate eyes, nose, throat, and lungs. Skin Contact: Mild to moderate skin irritant. Some clinical reports suggest a low potential for sensitization upon exaggerated exposure to sodium hypochlorite, particularly on damaged or irritated skin. Eye Contact: Moderate eye irritant. Ingestion: May cause nausea and vomiting if swallowed.

Chronic Health Effects: MSDS states that occasional clinical reports suggest a low potential for skin sensitization upon exaggerated exposure to sodium hypochlorite if skin damage (e.g., irritation) occurs during exposure. Routine clinical tests conducted on intact skin found no sensitization in the test subjects.

### **Handling/Disposal**

Handling: MSDS: Keep out of reach of children.

Do not get in eyes or on clothing. Avoid prolonged or repeated skin contact. Avoid prolonged breathing of vapor. Use only in well ventilated areas. For sensitive skin or prolonged or repeated exposure, wear rubber gloves.

Product reacts with other household chemicals such as acid toilet bowl cleaners, rust removers, acids, vinegar, and ammonia-containing products to produce hazardous gases such as chlorine and chlorinated compounds. Prolonged contact with metal or old porcelain may cause pitting or discoloration.
